Position Summary

Under general supervision, performs skilled work in setting up, operating, and maintaining sheet-fed offset presses and related equipment.

Essential Duties and Responsibilities

This list of Essential Duties and Responsibilities is not exhaustive and may be supplemented.

- 1. Operates high-production offset presses to reproduce materials using halftones, solids, color, etc.
- 2. Adjusts paper size, impression placement, paper thickness, and speed control of presses.
- 3. Operates electrostatic master imager.
- 4. Prepares chemical solutions for sensitizing and cleaning metal offset plates.
- 5. Cleans, adjusts, services, and makes minor repairs on presses.
- 6. Checks reproduced materials for imprint clarity and intensity.
- 7. May operate fully automated offset presses (simplex and duplex).
- 8. Sets up/operates padding equipment and paper-cutting, folding, collating, perforating, stitching, binding, and drilling machines.
- 9. Packs and wraps completed work for delivery.
- 10. Operates Xerox copy machines and other related equipment.
- 11. Performs preventive maintenance tasks.

- 12. Conforms to safety standards, as prescribed.
- 13. Performs other tasks related to the position, as assigned.

Distinguishing Characteristics

Involves operation of a sheet-fed offset press in reproducing printed materials.

Knowledge, Skills, and Abilities (Position Expectations)

- 1. Knowledge of offset shop equipment, materials, and techniques.
- 2. Ability to follow instructions.
- 3. Ability to learn and apply established procedures.
- 4. Ability to interpret and follow written/verbal instructions.
- 5. Ability to work rapidly and accurately under pressure.
- 6. Ability to plan and organize work assignments.
- 7. Ability to make minor equipment repairs.
- 8. Ability to perform general mathematical calculations.
- 9. Ability to relate well with administrators, employees, and the public.
- 10. Ability to perform tasks involving heavy lifting, dexterity, and coordination.
- 11. Ability to recognize and report hazards and apply safe work methods.
- 12. Possess physical and mental stamina commensurate with the responsibilities of the position.

- 2. Two (2) years' experience in operation/care of sheet-fed offset presses and related equipment.

Strength

Medium - exert force of 20 to 50 lbs., occasionally; 10-25 lbs., frequently; up to 10 lbs., constantly.

Climate-controlled office setting with temperatures ranging from mild to moderate cold/heat. Exposure to noise levels ranging from moderate to loud for occasional to frequent time periods.

Hazards

Furniture, playground/office equipment, communicable diseases, chemicals and fumes (as related to specific assignment), and power/hand-operated equipment and machinery (as related to specific assignment).

Offset press, process camera, film processor, computers, printers, scanners, collator, paper cutter, laminator, telephones, calculators, copy machines, fax machines, various hand tools, cleaning solvents, filing cabinets/equipment, etc.
