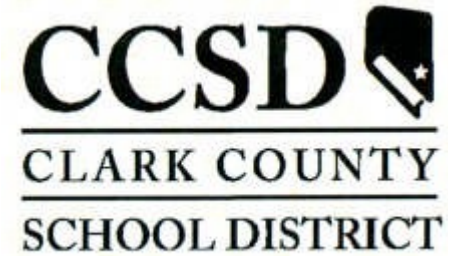

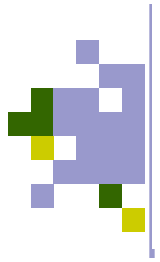
TRANSPORTATION INFO

Students living more than two miles from the campus will be provided transportation to the Peterson campus. Students and parents should understand that transportation to school is a PRIVILEGE, NOT A RIGHT. Therefore, all CCSD rules and regulations must be adhered to or bus privileges can be revoked.

If a student misses the bus, or, it does not stop at the assigned pick-up point, students should:

1. Call the school secretary at 799-6610
2. Notify transportation at 799-8110
3. Have parent/guardian bring them.

No student attending Peterson Behavior may drive a vehicle to school. Any vehicle will be towed if it is determined that a student attending Peterson drove the vehicle to school.



Peterson Behavior Overview

The Peterson Behavior Program serves as a short term intervention program (usually 4 – 9 weeks) for secondary students who have committed disciplinary infractions at their comprehensive schools. Students who attend the Peterson Behavior Program are expected to return to a comprehensive school upon completion of the program. The Peterson Behavior program provides required academic courses to students in a structured environment with emphasis on assisting the students in improving self-control, social interaction, and instilling life skills.
