- 3.03 APPOINTMENT OF LIAISONS. Jim Halsey, Chair, requested this item be held over to the next meeting.
- 3.04 LEGILATIVE SESSION UPDATE. Joyce Haldeman, Community and Government Relations, and Bond Oversight Committee member, provided historical background and information on the following assembly and senate bills that have an impact on school construction:

AB46: Provides for an increase in property and sales tax for Washoe County School District to generate funds for capital projects that requires approval by the Washoe County Commission. Ms. Haldeman expressed concern that if the county commission is able to approve a tax increase, they would also be in a position to determine how the tax revenue could be spent. (Clark County School District has property tax, real estate transfer tax, and hotel room tax revenues.)

AB459: The Oversight Panel for School Construction was created in 1989 to provide oversight on the use of the real estate and hotel room tax revenues. This panel will now meet only if the panel has approved the issuance of general obligation bonds.

SB350: Allows the Clark County School District to purchase school busses with construction funds.

SB522: Requires kindergarten class sizes be comprised of 21 students for each teacher. Ms. Haldeman explained this requirement will require up to four additional classrooms to meet this requirement.

SB504: Authorizes and establishes requirements for "ZOOM" Schools. ZOOM Schools are designated based upon schools that have a high population of English language learners (students that do not speak English) and have the lowest test scores. Each school is required to have Pre-K for every student, full-day Kindergarten, 21 students for each teacher, free summer school, and a reading development center. Ms. Haldeman also explained that the Legislature did provide significant funds for facilities related to these programs.

Nicole Rourke, Government Affairs, provided information on the following assembly bills:

AB50: Extends the City of Las Vegas' redevelopment agency by 15 years. The original approval was for 30 years and now extends it to 45 years. In 2011, the 18 percent of property tax that was set aside for affordable housing was divided so that 9% would go towards education. In 2032, education will receive the full 18 percent.

AB417: The City of Henderson also pursued a change to their redevelopment agency and if the reset is passed, the District will receive 18 percent set aside, similar to the City of Las Vegas.

AB85: Eliminates the ability of local government agencies to join contracts with other public entities as part of a licensed contractor.

AB172: Limits the requirements for design professionals and design build teams. Eliminated the requirement for a percentage of supplies/materials of a public work be located in the State of Nevada. The threshold for material breach of the contract was changed, and the voiding of the contract upon the material breach. Replaced liquidated damages for a penalty.

AB283: Amends certain requirements when a public body decides to contract with a construction manager at risk.

AB294: Provides a system developed by the Governer's Office of Economic Development that will authorize businesses as small emerging businesses. The public entity will be required to report on the small emerging businesses that submit a bid and are contracted to perform.

SB142: Helps school districts find ways to fund construction projects through performance contracting. This bill requires a policy to be adopted.
