- Middle, junior high or elementary schools will be named for pioneers, educators or prominent citizens or Clark County
- School facilities or buildings, which includes libraries, athletic fields, multi-purpose rooms, theaters, etc. may be named for former district employees or citizens who have made specific contributions to education in Clark County, provided the high school is not named for an individual
- Names of district personnel will not be considered while actively employed by the Clark County School District
- Names of Board members may not be considered while actively serving on the Board of Trustees, in accordance with NRS 338.200.
