Dear Members of the Clark County School District Board of Trustees:

I am writing to express my interest in the Clark County School District Board of Trustees District D position. I am presently an Assistant Professor in the Educational Psychology and Higher Education Department at the University of Nevada, Las Vegas and resident of District D. As an educator, researcher, and school psychologist, I believe that my diverse professional experiences have prepared me well for this remarkable opportunity. The responsibilities and duties included within this role are consistent with my own goals: to promote and support the high school graduation of all students in Clark County School District and to prepare them to be positive contributors to our global community

I have had the opportunity and pleasure of working in a variety of roles in the field of education. Over the course of several years, I have worked as a special education teacher for students with severe emotional disturbances and for students who were medically fragile and homebound. During this time, I was intimately involved in the development, and monitoring of each child's individualized education plan. I worked extensively with medical and mental health teams to develop multiple support channels for my students. I later worked as a bilingual school psychologist. In that role, I advocated for fidelity in intervention implementation and was committed to working with teachers, families, and administrators before students were placed in special education or moved to more restrictive placements. I promoted advocacy, working with parents and families to help them understand the importance of their role in the education of their children. My motto for these collaborations was that as a team we must be "both realistic and optimistic." In this way, we had to be "realistic" in order to accurately assess the needs of the students, but also remain "optimistic" that anything is possible with collaboration, hard work, and a willingness to think creatively.

This motto has successfully carried over into my work at the University of Nevada, Las Vegas. My current position as an assistant professor allows me to share my passion for education with my students. In my courses, I seek to promote cultural competence as well as their realism and optimism by integrating theoretical foundations, practical experience and current research into their course requirements. My goal is to encourage my students to be well-rounded practitioners and knowledgeable consumers of research.

Additionally, my research agenda is focused on the practical application of and implications for screening for behavioral and emotional risk in schools. Specifically, I have been focused on the intersection of behavioral and emotional risk screening and mitigation of the over-representation of children of color in special education programs. In conducting this research, I collaborate with school districts and school committees regularly to develop research questions, facilitate data collection, and disseminate findings. Specifically, I have worked with school district level administrators to implement innovative solutions to disciplinary, disproportionality, and special education related issues.

Furthermore, as an assistant professor, I have been working with university and college level committees to develop strategies to support faculty and students both through

existing and new programs. Specifically, I have been working with the College of Education scholarship committee to increase financial support for the scholarship and identify students who would most benefit from the support.

I have been actively engaged in helping to contribute to resolve educational issues facing the Las Vegas community. I have been working with the Nevada Partners to collect the necessary data to seek additional external funding for their programming. I have also been working with the Downtown Achieves project encouraging the use of data-based initiatives to increase student performance at the target schools. Additionally, I sit on the business advisory board for the Uplift Foundation, which is dedicated to promoting scholastic and social/emotional achievement in young men of color in the Las Vegas Valley.

As a result of my professional experiences as a special education teacher, bilingual school psychologist, university professor, and researcher, I believe that I have the skills, attitude, knowledge, and strategies required to represent the needs of the Clark County residents in District D. As a resident of District D, I feel committed to directly fostering the academic excellence of my neighbors and friends. I look forward to hearing from the selection committee.
