2024 Secondary Summer School
Frequently Asked Questions

Q: When does summer school start?

A: Session I: May 28 – June 14. Session II: June 17 – July 8.
There is no school on June 19 (Juneteenth) and July 4.

Q: Who will notify me if my child needs summer school?

A: Your student's counselor.

Q: Can I register my student online for summer school?

A: No, the school counselor completes registration.

Q: When is the last day to register my child for summer school?

A: May 22, 2024.

Q: Will there be Transportation provided?

A: No.

Q: Are there online summer school classes offered?

A: Yes, online summer school courses will be offered through NVLA.

Q: Is there a fee for summer school courses?

A: Classes are free to current Clark County School District students.

Q: How many days can my child miss during a summer school session before being withdrawn?

A: Students will be withdrawn from secondary summer school on their fourth absence.

Q: Can my child take the final exam early if we are scheduled to go on vacation?

A: No, final exams may not be taken early.

Q: How many hours a day will my child be in class?

A: Five hours. There is a 15-minute nutrition break.

Q: What are the hours of summer school?

A: 7:30 am - 12:45 pm.

Q: How many credits can my child earn per session?

A: .5 credits.

Q: Can a student from out-of-state, charter, or private school enroll in summer school?

A: No. Students not actively enrolled in a CCSD school can't register for summer school.

Q: Are incoming “out of state” students moving to Las Vegas after the 23/24 school year be permitted to attend summer school?

A: Charter, private, and out-of-state students should contact Nevada Learning Academy to inquire about the registration process.

Q: Will breakfast and lunch be offered to summer school Students?

A: No.

Q: Can I pick my child up early from summer school without it being counted as an absence?

A: No.

Q: Will there be staff out to assist my child with getting to the correct class on the 1st day of summer school?

A: Yes.

Q: Does the school district offer summer school for elementary school students?

A: CCSD does not offer summer school for elementary school students.

Q: Who should I contact for further information regarding summer school?

Q: Who do I call to change summer school sessions or summer school courses that my child has signed up for?

A: To change sessions and courses, contact your child’s counselor.

Q: Will my child be automatically registered and enrolled in summer school if I have yet to be contacted?

A: Possibly, you must contact your student’s counselor to confirm that summer school registration has been completed.

Q: Is there any paperwork that I should receive, sign, and return to the school to enroll my child in summer school?

A: Contact your student’s counselor, log in to Infinite Campus, and check your USPS mail and voicemail to ensure that a counselor has not attempted to contact you. Some information may have been sent to parents.

Q: How do I change a class my child is registered for?

A: Only your child’s counselor can make schedule changes

Q: How do I know which course my child needs to be promoted to the next grade?

A: Please contact your child’s school counselor to discuss which classes your child should take and any other information about their academic needs. Counselors will be available during Walk-in Registration at each designated site.

Q: Can my child take classes to get ahead in school, or is it just to make up for failed classes?

A: If your child is a middle school student, summer school is only offered for credit recovery. Please speak to your school counselor if your student is a high school student wanting to take classes to get ahead.

Q: How can I check if my child is registered for summer school?

A: Log into your Campus Portal. If your child is registered, information will appear on the screen, including which class and which session. If this information does not appear, then your child is not registered, and you must contact the school counselor.
