Rick Baldwin reviewed Attendance Zone Advisory Commission's proposal to adjust the attendance zone boundaries of Lomie G. Heard Elementary School, Mary & Zel Lowman Elementary School, and J. E. Manch Elementary School. As of June 2016 Heard Elementary School will no longer operate as a Clark County School District school on Nellis Air Force Base. As a result of the school closure it is necessary to reassign their current students. It is proposed to reassign the students from Heard Elementary School to attend Lowman and Manch Elementary Schools beginning the 2016-2017 school year.
